नजर रखे हुए है कि कहीं दो समुदायों में तनाव की आड़ में असामाजिक तत्व किसी भी प्रकार की गैरकानूनी गतिविधियों को अंजाम न दें सकें।
 बताया जा रहा है कि अभी तक पुलिस और जिला प्रशासन से प्रदर्शन को लेकर किसी भी प्रकार की अनुमति नहीं लगी गई है। एरापी शिमला संजीव कुमार गांधी ने कहा कि संजोली में सुरक्षा के पुख्ता इंतजाम किए गए हैं। हर स्थिति पर कड़ी नजर रखी जा रही है।

कं वहीत पंचायत बरटा क एक घर स पाइथन प्रजात क एक लखाल अजगर को रेस्व्यू किया है। अजगर के पकड़े जाने पर ग्रामीणों ने राहत की सांस ली है। सुंदरनगर में सुकेत वन मंडल अधिकारी राकेश कटोच ने कहा कि सोमवार प्रातः बंदोरी पंचायत के ग्रामीणों की एक घर में बड़े सांप की जानकारी प्राप्त हुई। वन विभाग में एक टीम ने घटना स्थल पर पहुंच कर सांप को रेस्व्यू करने में सफलता प्राप्त की है। यह सांप नाग प्रजाति के पाइथन अजगर है और साइज में काफी बड़ा है। स्थानीय पंचायत चौकीदार सोहन लाल ठातुर ने कहा कि इस सांप के पकड़े जाने से ग्रामीण भय मुक्त हो कर राहत की सांस ली है। उन्होंने कहा कि कई गरीबों से इस सांप जिसे स्थानीय भाषा में सराल तथा विभाग के अनुसार नाग पाइथन अजगर के रूप में जाना जाता है। इस सांप को कई देख चुके थे, जिसका पता चलने के बाद गांव में घारा तक काटना बंद कर दिया था। उन्होंने कहा कि निकट ही एक घर खाली था, जिसमें लकड़ी रखी हुई थी। आज सुबह जब घर के मालिक लकड़ी उताने आए, तो यह सांप देखा।
